Mattingly and Harman was commended for repairing and cleaning tables and benches in the pavilion area and for removing all concrete debris from the pool repairs. Mann noted a possible gift of #200-Section III for back assessments owed and asked those interested in making bids when title cleared to sign register.(3) signed with Secretary for forms when available. 1983 Minutes read and approved on motion by Cleo Martin, sec by Betty Baker.MC Financial Report read. Motion by Martin, sec. by Sheffield to accept for Audit. Mann noted Commissioner had mowed bar ditches and roadsides, filled some pot-holes and would do some re-topping of Big Bow when funds available. Aqua Water letter read concerning mandatory water restrictions and penalties if violated.Complaints of go-carts operating in area heard. Member advised that Board has NO authority to enforce..must be filed with county legal authority for action. Forms available from Billie Owens. Nominating Com. Chrm Jim McGinnis listed name of Joyce Reilly, with name of second nominee having withdrawn just prior to meeting. Nominated from floor was Curtis Cone. No other nominations, closed and Reilly and Cone were declared elected for the two Board vacancies. Each presented and made brief statements. Ella Sheffield introduced as Registration chairman, assisted by Libby Owens & Louise Naumann, all thanked for their services. REPORTS: Membership, James Naumann, absent/LAKE & FISHING-Jim McGinnis noted feeding of fishat annual cost of \$150.00 had brought excellent results. Barber, Williams, Nickel & Mattingly assisted with fertilizing and weed eradication program... 1 7# Bass & 1 19" bass reported caught.Committee recommended both programs be continued, with Coves treated with Herbicides during cool months, but only after Board is informed of intent by cove property owners.

DELINQUENT ACCOUNTS-Turner read report -filed.101 members delinquent-8 set for trial in August- 24 delinquent two years or more. Attorney had collected \$1182. to date, on percentage basis. Billie, David & Libby Owens thanked for help with Architechtural Committee and for Computer print-outs of membership, etc. Reported six new applications on file for housing at ILOA., with Architectural Committee, chrm. Pool-Turner noted 180 families using POOL with increases on weekends. Member requested that foot tub be cleaned more often and commended Pool Guards for kindness and courtesy. Use of guest cards explained-limited to home-owners guests- not to include GROUPS- such as Scouts or Church Groups. Request that small children not be dropped off at pool without supervision. Pool Guards do not perform child care services. Pool seating desired and Board assured members that this would be provided shortly. STREETS & ROADS-Harman reported street signs ordered at cost of 716-94 with delivery in 30 to 45 days, freight collect. Old signs will be salvaged where possible, and refurbished. Maps given to Post Office to facilitate mail deliveries, designating Big Bow as North or south...adding Indian Lake to address. 1984 Audit reported by Committee as in order. Copy in Files. Trash Dump area violations noted as motor parts, building materials in large boxes, too heavy for hauler to handle, not household trash, could result in hauler resigning. Mailing of Financial Statement and Minutes of July meeting to all members with the January 1985 statements, approved. Board presented Mr. Mann a PLAQUE as a memento of his seven years service. Everyone was reminded of Annual Picnic at Pavilion area. Letter of Resignation of Ervine Nickel read and Frank Naumann, appointed to unexpired term, welcomed
