Signs-Streets and roads: Sign at entrance noting area being restricted for homes, trailers, etc....with Architectural permits required -- is now posted. Sebastian trailer area cleaned-now sold with remodeling in progress. Vandalism noted on 296,297-Deer Run-Lock broken & reported. Blain lot 110-IJ inspected for fence complaint-measured and matter cleared. Posting of Minutes on Bulletin Board- Reilly volunteered to handle matter. President McGinnis thanked her for the offer, and accepted.

Report of ransacked trailer by stranger(female) investigated. Not valid. Discussion on members buying extra lots terminated for report of Frank Naumann's Budget Graph.

Maintenance in Pool and shower area discussed...repairs made by Hildman...
rotting wood is area reported. Discussion: Also on matter of Diving Board for Pool...request that storage items be moved from box to pump house..that the extra motor be purchased for continued summer use, as a spare back-up. Discussion...Mann reported Denmons visit and request, also strangers hauling trash and dark garbage bags into Indian Lake area for collection and disposal. Discussion on manner to handle problem,, no action immediate.

Lake- Mattingly reported that poisoning of weeds around lake edge had not done due to weather...also nutria are becoming a hazard in the lake..great numbers are destroying the boat-dock-Raft floats, etc in the Lake, plans to control them will be investigated.
