WHEREAS, the Texas Water Rights Commission finds that jurisdiction of the application is established, due notice and publication thereof having been accomplished, and hearing having been held, all in accordance with the Texas Water Code and the Rules and Regulations of the Commission.

NOW, THEREFORE, this permit to appropriate State water is issued to Indian Lake, Inc., subject to the following terms and conditions:

1. IMPOUNDMENT

Permittee is authorized to maintain an existing dam and reservoir on an unnamed tributary of Gravelly Creek and impound therein not to exceed 540 acre-feet of water. Station 4+20 on the centerline of the dam bears N 71° 50' E, 3340 feet from the SW corner of the Charles Edwards Survey, Abstract No. 30, Bastrop County, Texas, 5 miles NE of Smithville, Texas.

2. USE

Permittee is authorized to use the impounded water for recreational purposes with no right of diversion from the impoundment.

This permit is issued subject to all superior and senior water rights in the Colorado River Basin.

Permittee agrees to be bound by the terms, conditions and provisions contained herein and such agreement is a condition precedent to the granting of this permit.

All other matters requested in the application which are not specifically granted by this permit are denied.

This permit is issued subject to the rules and regulations of the Texas Water Rights Commission and to its right of continual supervision.
