EDITOR'S COMMENT

To All Property Owner's and Renter's:

First of all a special thanks to all the individuals that have been cleaning up around the area, especially around the dumpsters throughout the year and participating in the recycling program. However, there are plenty of individuals who are not helping.

The main topic of this newsletter is the dumpster area and the recycling program. Our biggest concern is the dogs and the dumpsters. There are three dumpsters provided for trash pickup twice a week on Mondays and Thursdays. These dumpsters should be adequate for our community size if all owners and renters start and continue to use the recycle program. This program got off to a fairly good start, but the second weekend did not prove to be as successful. The area around the dumpsters on several weekends in the past has been a disastrous sight. If the dumpsters are full and overflowing, please wait until after the dumpsters have been emptied. The trash collectors will not remove any excess trash surrounding the dumpsters, so please don't hold all your trash bags until the dumpsters are reaching their full limit. The trash must be inside the dumpster with the lids closed to prevent all the stray dogs from getting in and pulling bags out to be scattered about. Trash contents should include household trash items only, does not include old rugs, furniture, and/or bags of leaves.

We had hoped that by bringing in a recycling trailer every other weekend would help prevent this overflow problem. A sign is posted at the entrance to remind you of the weekend the trailer is here. Please save and hold your recyclables at home until the trailer arrives. A reminder on the recyclable items are as follows: glass, cans, paper, cardboard, plastic, iron, and tin.

If we all don't pull together on keeping the dumpsters from overflowing, we are left with no other choice, but to purchase another dumpster. The cost of this purchase will be \$130.00/a month for each additional dumpster. Of course, that means the maintenance dues will have to increase. Please don't make us resort to this last effort, and pitch in to help us keep the dumpsters from overflowing and do your share to RECYCLE.

Another complaint that seems to be a never ending battle is all the littering on our streets, such as throwing beer cans, bottles, and paper out of vehicles. If anyone witnesses this action, please notify the proper authorities to have charges brought against the person responsible for this type of behavior.
