In December 1994, the newsletter stated that, "If the dumpster situation did not improve, we will go to our own individual trash pickup". Effective July 1, 1995, the dumpsters will not be available for your household trash. There have been some owners, renters, and outsiders who don't understand what household trash is. The dumpsters have been filled up and piled outside of with everything from building materials, bags of leaves, appliances, old mattresses, etc. These non-household items take up so much space in the dumpsters that individuals are left with disposing of their household trash bags on the outside of the dumpsters for the dogs and birds to tear up and scatter around. I'm sure everyone has seen this mess many times in the past two years. This, in turn, creates a health hazard for those of us that are left with cleaning this trash area.

You will have to make your own arrangements to dispose of your household trash effective July 1, 1995. The options that are available for the subdivision are as follows:

1.) Action Disposal, 1-800-873-4810, or 2.) you may haul your own household garbage to Lost Pines Industries, Inc. (LPI) in Bastrop 512/321-7071 for a small fee. The recycle program will also be discontinued effective July 1, 1995. For those who wish to continue helping out our environment, you can take your recyclables to Smithville Recycle or Lost Pines Industries, Inc. (LPI) in Bastrop.

Brush burning across from the Pool will also be stopped. The new location for this burning will be moved down by the small pond, so you will have a place to dump your brush. Brush only, please. Make note that we will continue to have our yearly cleanup in January.

The Board has received many questions as to whether the Association dues will be decreasing. There are definitely no plans to reduce the dues as of now or in the near future. The \$60.00 a year, which breaks down to \$5.00 a month, that we are paying now seems like a minimal fee. These dues are used for maintenance of the Lake, boat ramp, dam, swimming pool, front entrance, and administration costs. The volunteers that are on the Board are doing a terrific job of keeping the subdivision looking as good as it does, so when you see one of these volunteers, you might want to say Thank-You for a job well done.
