**PAVILION RESERVATION FORM**

The fee to reserve the Indian Lake Owners Pavilion is \$25 (non-refundable), with an additional \$75 refundable deposit required.

To complete your reservation, please fill out and sign this form and return it to an ILOA Board Member, you can contact an ILOA Board Member by calling 512-237-8500.

An Indian Lake Owners Association representative will inspect the Pavilion area before and after your event to determine if the full \$75 dollar deposit will be refunded. A refund will be issued (check returned/destroyed) within 30 days of your party/reservation.

**Terms, Conditions, and provisions of this Agreement, and Release of Liability:**

1. The **“Host”** is hereby defined as a member of **Indian Lake Owners Association**, the person making this reservation, and the responsible party in this agreement. In the event of multiple hosts, the **“Primary Host”** will assume any responsibility listed in this agreement.
2. The Pavilion is available for reservation by Indian Lake Owners Association members between the hours of 8 AM and 10 PM. Reservations must be made as least 1 week in advance. Reservations will not be accepted more than three months in advance. Reservations will not be accepted by any “Host” who are not current with their association dues.
3. All “Host” signing this agreement must be present at the event always, including during setup and cleanup.
4. Reservations only include the pavilion, and picnic tables within the pavilion area. The rest of the park area will remain open to other Indian Lake Owners Association members.

5. After each use of the pavilion, "Hosts" are required to leave the space in the same condition as before the event. This includes but is not limited to disposing of all garbage and cleaning the tables. Garbage must be physically removed from the pavilion area to be considered disposed of.
6. The "Host" is responsible for all alcohol consumption of all guests and for compliance with alcohol beverage laws and regulations. The "Host" expressly assumes all social liability which may arise out of, or relate to, the use or occupancy of the pavilion.
7. The "Host" is responsible for the conduct of all guests. The "Host" expressly assumes liability for all damage to the pavilion, its fixtures and furniture, or to the related common areas, which arises out of or relates to the use or occupancy of the pavilion.
8. The "Host" expressly agrees to release, indemnify and hold harmless Indian Lake Owners Association, and their respective officers, directors, agents, employees, independent contractors, and volunteers (the "Released Parties") from any and all harm, damages, claims, fines, suits, demands, actions, or other liability, including without limitation personal injury, death, or property loss of any person, and including costs and expenses of any kind or nature whatsoever including without limitation attorney's fees, which arises out of, relates to or results from the use or occupancy of the pavilion and related common areas.
9. The "Host" shall comply with all stated and customary terms, State and federal laws, posted safety signs, rules, and verbal instructions as conditions for utilizing the Pavilion. If the "Host" observes and hazardous activity during their event, they must bring it to the attention of an Indian Lake Owners Association Board Member or an appropriate official immediately.
10. The "Host" understands that there are inherent risks associated with the use of the pavilion, parties, and/or use of the area, and knowingly and freely assumes all such risks, both known and unknown, including those that may arise out of the negligence of other participant(s), and their respective heirs, assigns, administrators, personal representatives, and next of kin, hereby release and hold harmless, Indian Lake Owners Association, their affiliate, officers, agents, employees, and sponsoring agencies from and against all claims, injuries, liabilities or damages arising out of or related to our use of the pavilion.
11. It is your responsibility to manage any dispute that may occur if multiple groups vie for use of the pavilion during your event. The official reservation of the park pavilion conveys first rights to use the pavilion for your group: however, it is not legally binding. If any disputes happen during your event, please address them civilly and attempt to come to a compromise. If you have officially rented the park pavilion from Indian Lake Owners Association, and the other group(s) that show up to use the area, this printed agreement then exceeds any claims that group may have to the pavilion usage.
